AMENDEMENT OF RULE NUMBER VIII.G.7 CONCERNING
THE GUIDELINES OF FINANCIAL REPORT PRESENTATION

CHAIRMAN OF INDONESIAN CAPITAL MARKET SUPERVISORY AGENCY,

- Considering :
- a. That in order to perform the disclosure principles, Issuers and Public Companies must submit financial report which is presented under the generally accepted accounting principles;
 - b. That in order to improve the disclosure quality of financial report of the Issuers and Public companies and to establish good corporate governance, provisions concerning the guidelines of financial report presentation should be adapted to the Financial Accounting Standard;
 - c. That with regard to the matters above, it is considerable to amend rule number VIII.G.7 attachment of Decision of Chairman Bapepam Number Kep-97/PM/1996 dated May 28, 1996 concerning the Guidelines of Financial Report Presentation

Decision of Chairman of Bapepam Concerning Amendment of Rule Number VIII.G.7
Concerning the Guidelines of Financial Report Presentation

Article 1

Provisions concerning the Guidelines of Financial Report Presentation are regulated in Rule Number VIII.G.7 as stipulated in the attachment of this decision.

Article 2

Provisions under this decision are required for financial report beginning at or after January 1, 2000.

Article 3

As this decree becoming effective, the Decision of Chairman of Bapepam Number 97/PM/1996 dated May 28, 1996 is declared revoked.

Article 4

This decision shall become effective since the date of its promulgation.
