Considering : that in order to improve the professionalism and independency of an Accountant acting in Capital Market, it is necessary to up date Bapepam Rule Number VIII.A.1 concerning Registration Of A Public Accountant Operating In The Capital Market, Attachment of Decision of Chairman of Bapepam Number Kep-37/PM/1996 dated January 17, 1996 by enacting Decision of Chairman of Bapepam;

In view of :

1. Law Number 8 of 1995 Concerning Capital Market (Statute Book Year 1995 Number 64, Supplement to the Statute Book Number 3608);
2. Government Regulation Number 45 of 1995 Concerning Capital Market Organization (Statute Book Year 1995 Number 86, Supplement to Statute Book Number 3617);
3. Government Regulation Number 46 of 1995 Concerning Capital Market Formal Investigative Procedures (Statute Book Year 1995 Number 87, Supplement to Statute Book Number 3618);
4. President of Indonesia Decree Number 7/M of 2000;
5. Decision of Chairman of Bapepam Number Kep-37/PM/1996 date January 17, 1996 concerning Registration Of A Public Accountant Operating In The Capital Market;

HAS DECIDED:

Article 1

Provisions concerning Registration of Accountant Engaging in Capital Market Activities are regulated in Rule Number VIII.A.1 as stipulated in the attachment of this Decision.

Article 2

Accountant who has a license from Bapepam before the enactment of this decision, shall fulfill the document required by this Decision, not later than 6 (six) months since the enactment of this Decision.

Article 3

With the enactment of this Decision, Rule Number VIII.A.1 concerning Registration of Accountant Engaging in Capital Market Activities, Attachment of Bapepam's Chairman Decision Number Kep-37/PM/1996 dated January 17, 1996 is declared revoked.

Article 4

This decision shall become effective since the date of its promulgation.
